Test results

According to the test results of page 2-6 the material fulfils the requirements of building materials class B1 and B2 according to DIN 4102-1.

The present test samples (see page 2) can be classified according to the **DIN 4102 part1 (1998-05)** into the following class:

Baustoffklasse B1 (schwerentflammbare Baustoffe - hardly flammable)

Results: The examined product meets the requirements of class B1 for "schwerentflammbare" (hardly flammable) building materials according to DIN 4102, part 1 (1998-05), suspended freely or with distance of >40 mm to same or other plain materials.

Special remarks:

- This report in only valid for the material as described under paragraph 1 (see page 2). In combination with other materials or with additional coatings or grounds etc. the burning behaviour may differ.
- This test report is not valid for the exposure to outdoor climate conditions.
- This test report is not valid, as soon as the fabric is used as a building product in the sense of the "Landesbauordnungen" (state building requirements, MBO §17, par. 3).
- This test report is no substitute for a General Building Inspectorate Certificate.




fig 1: Graphs of the flue gas temperature and the smoke density




fig 1: Graphs of the flue gas temperature and the smoke density




fig 1: Graphs of the flue gas temperature and the smoke density




fig 1: Graphs of the flue gas temperature and the smoke density
